Tashir Medica and Nearmedic Plus announce partnership in healthcare

Tashir Medica (part of Tashir Group) and Nearmedic Plus have signed a memorandum of understanding on partnership in healthcare. The partnership will include a number of innovative and strategic projects which will significantly improve the quality and accessibility of healthcare services in Russia.

The companies intend to work together closely in a number of areas, especially introducing innovative infrastructure and technological solutions to modernize and develop clinical and diagnostic laboratories in various parts of Russia, including public-private partnership mechanisms. In addition, the companies plan to create special centers for proton and ion therapy for cancer treatment, as well as to design



and market new products and services in the fields of genetics, genetic engineering and forensic science.

The parties are interested in offering turnkey solutions for complex healthcare projects, including all the life cycle stages – designing, building, equipping and operating new healthcare centers. Given Tashir Group’s extensive experience in construction, the partners are considering implementing construction projects in healthcare on a turnkey basis.

The parties have also agreed to cooperate through joint investment in innovative pharmaceutical projects.

The partnership between Tashir Medica and Nearmedic Plus is based on utilizing both companies’ strengths to achieve common goals.

Also, Tashir is working on the “hospital of the future” at Moscow’s Medical Cluster in Skolkovo.
